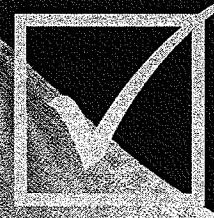

PRIMARY ELECTION

Important Dates

December 24, 2009 First day absentee ballot applications are accepted.

January 5, 2010 Last day to register to vote.

January 6, 2010 First day of grace-period registration and voting.

January 11, 2010 First day of early voting.

January 26, 2010 Last day of grace-period registration and voting.

January 28, 2010 Last day military and overseas voters may make application for ballot and send out ballot.

January 28, 2010 Last day of early voting.

January 29, 2010 – February 1, 2010 In-person absentee voting at the Clerk's downtown Chicago office only.

February 1, 2010 Last day voted mail absentee ballots can be postmarked for acceptance by the Clerk's office.

February 2, 2010 Election Day
