To the Members of Sprinkler Fitter Union Local 281, U.A.

Dear Brothers and Sisters:

At the regular monthly meeting held on May 6, 2010, the members present voted to allocate the \$3.30 per hour raise to wages effective June 1, 2010.

The new Journeyman rate effective June 1, 2010 is \$49.20 per hour. The new Foreman rate effective June 1, 2010 is \$51.20 per hour.

The Election of Officers will be held on **Sunday, June 6, 2010** at the Operating Engineers Local 150 Hall, 6150 Joliet Road, Countryside, Illinois. The polls will be open from **10:00 a.m. until 2:00 p.m.** All Journeyman members in good standing will be eligible to vote in the Election of Officers. Sprinkler Fitters Local 281, U.A.'s election guidelines do not allow for absentee voting. Therefore, as in previous elections, there will be no absentee ballots available.

In the case of a tie, a run-off election will be held at the regular monthly meeting on Thursday, July 1, 2010 at 8:00 p.m. at the Operating Engineers Local 150 Hall, 6150 Joliet Road, Countryside, Illinois. The run-off election would only be for the candidates/offices that resulted in a tie at the Election of Officers.

A list of the Offices to be nominated is enclosed. The term of office will run for three years beginning July 1, 2010.

The next regular monthly meeting of Sprinkler Fitters Union Local 281, U.A. will be held on Thursday, June 3, 2010, at 8:00 p.m.
